#### REPORTS FROM PRIORITY AGENCIES

## **Operations Reports from City Departments, Consultants and Outside Agencies**

Dr. Barry Pressman presented information from the Metropolitan Water District (MWD) regarding water conservation and the State Water Project Dependent areas, including an update regarding the low water surplus and drought management. A Water Shortage Emergency Condition has been declared and an Emergency Water Conservation Program approved in April 2022.

## 2. Organics Update

Solid Waste Manager James Burnley reported on SB1383 and the goal to reduce organics in the landfill. He presented information on the City's efforts to collect organics and food recovery programs. Collection of multifamily organics will begin in July 2022. The Commission commented and provided feedback.

## 3. 2022 Public Health Goals Report

Water Quality Specialist Jason Dyogi presented the Public Health Goals Report (PHG). The presentation indicated all of the previous detected constituents that were above the non-enforceable goals. An explanation and comparison table was provided to demonstrate the differences between the non-enforceable goals versus the enforceable maximum contaminant level standards set by the regulating bodies. It was concluded that the City's drinking water meets all of the California State Water Resources Control Board's (SWRCB) and the United States Environmental Protection Agency's standards in order to protect public health. Several questions and answers followed after the presentation.

## 4. Best Practices – Food Waste Management

Deputy Director of Public Works Michael Hensley Introduced Central Storeroom Supervisor Ruben Morales who presented a report on Food Waste Management. He highlighted France as a country that wastes less than the average country in the European Union and has been proactive in legislation and tax breaks to incentivize participation. In California, Senate Bill 1383, taking effect in 2022, requires 20% of edible food be recovered. Continued collaboration between food producers, government and non-government agencies, will be necessary to reduce food waste. The Commission commented and provided feedback.

#### PROJECT UPDATES & STATUS ITEMS

### 5. Foothill Water treatment Plant Update/La Brea Subarea Update

Water Resources Manager/Operations Vince Damasse gave a brief follow up on the Water Treatment Plant and its operation, and Project Manager Tristan Malabanan gave an update of the La Brea Subarea Project and the projected timeline. The Commission inquired about concerns with water sampling as well as delays with parts delivery and power installation.

#### 6. Water Efficiency Update

Public Works Director Shana Epstein commented about communicating the current water situation and diversifying our water portfolio. Water Conservation Administrator Debby Dunn reported on the severity of the drought and drought declaration actions currently being taken. Her recommendations include watering twice a week, per BH City Code, checking for leaks in running toilets and signing up for water tracker. Deputy Director of Public Works Michel Hensley updated the Commission on the improvements and proactive actions with our Facilities, Fleet and Parks Operations. The Commission inquired about enforcement of water violations.

## 7. Capital Projects Update

Public Works Director Shana Epstein relayed information about the Cabrillo Reservoir Project's public engagement beginning when the project is defined through the environmental review process. Responding to a Commissioner inquiry, to report uneven sidewalks/sidewalk concerns, call Public Works Customer Service at 310-285.2467 or send photos to AskPW@beverlyhills.org. Project Manager Samer Elayyan made further comment about sidewalk concerns during active construction. Utilities General Manager Rob Welch responded to an inquiry about Metro and the Canon Drive closure.
