Metropolitan Water District Director Dr. Barry Pressman reported on the specifics of the upcoming Water Inspection Tour. His PowerPoint presentation included details about the Colorado River Compact from 1922, which divided the right to use the water between the upper and lower basins.

# 3. Status update for the Water and Wastewater Cost of Service Study

Utilities General Manager Robert Welch introduced HF&H Senior Vice President John Farnkopf, who provided an update and cost-of-service analysis on the Wastewater and Water Enterprises. The Commissioners commented about seeking an equitable solution to single family and multifamily charges. There will be further discussion on this topic at a Special Meeting later in the month.

Director Epstein discussed the public hearing process moving forward and asked for comment on the following items: CIP options, the water fixed rate ratio of 17%, outside city differential, pass through rate adjustment, water reliability charge, and water shortage revenue stabilization rates.
