Metropolitan Water District Director Dr. Barry Pressman gave an update on the Water Inspection Tour that took place recently, the Water Surplus and Drought Management Report (WSDM) and the Water Shortage Emergency Conditions. The Commission discussed the updates and artificial turf.

6. Best Practices - Water Replenishment District Strategic Plan for the West Coast and Central Basins (Item Taken Out of Order, After TAB 2)

Public Works Director Shana Epstein introduced Water Replenishment District (WRD) Assistant General Manager Rob Beste. He presented on WRD's use of recycled water in replenishing the West Coast and Central Basins. The Commission discussed the system and desalination plants.

3. Proposed Stormwater Ordinance Amendment

Environmental Compliance and Sustainability Program Manager Josette Descalzo presented three proposed amendments to the stormwater ordinance. The amendments would affect prohibited discharges, requirements for existing projects, and the LID criterion on development projects. The Commission discussed the proposed amendments.

Alpert to approve the proposed amendments in lowering the Low Impact Development (LID) thresholds to comply with the current MS4 Permit and require simple LID BMPs on smaller development projects that do not trigger the LID. The amendments should also include allowing pool filter backwash to be discharged to the

sewer system. (3/0).

5. Metropolitan Water District's Colorado River Municipal Conservation Memorandum of Understanding

Utilities General Manager Rob Welch presented an update on MWD's request for the city of Beverly Hills to join a multi-agency MOU designed to reduce reliance on the Colorado River and on providing a recommendation to City Council on adopting an ordinance to restrict non-functional turf. The definition of non-functional turf was discussed with additional comments by Water Conservation Administrator Debby Dunn. The ordinance will be presented at a future date. The Commission discussed the MOU.
