#### COMMUNICATIONS FROM THE COMMISSION

- Chair Report
  - a) Mayor Cabinet Meeting
  - The Architectural Commission approved two new restaurants in Beverly Hills: The Beverly Bar and Breadblok.
  - The Arts and Culture Commission provided a report about Frieze Week and shared that guided art walks tours will continue on Sundays after Frieze ends.
  - The Cultural Heritage Commission chose three more Golden Shield Award nominees for Council consideration.
  - The Design Commission did not have a meeting.
  - The Health and Safety Commission received updates from the BHUSD.
  - The Human Relations Commission reported that Kindness week was February 13 –
    19. They noted that the CAGF application period closed on February 1, and staff received over 30 applications.
  - The Planning Commission approved the 331 North Oakhurst project. There was a first hearing for the LVMH Cheval Blanc Hotel. Hillel Academy is proposing a new building on Olympic.

- The Public Works Commission provided a water efficiency update and reminded us that we are still in a drought.
- The Parks and Recreation Commission noted that the preschool program returned to an in-person format. Adult and youth classes are back in session.
- The Traffic and Parking Commission kicked off a new educational speaker series this month regarding transportation-related issues.
- Comments from Commissioners
  - Chair Galen reminded the Commission that Commissioners used to meet with catering managers, hotels, party planners, and major event coordinators in the City to inform them that nonprofits need to file a permit with the City for their events. Commissioner Smith and Commissioner Galen will resume visiting these establishments.
- Other items, brief announcements, requests for information, and brief reports on activities None.

# **COMMUNICATIONS FROM STAFF**

Staff received a request from the Human Relations Commission to change the meeting from April 13 to April 20. Commissioner Lipton said he would not be able to join in person. Staff will check with City Clerk to see if it is possible to have the next meeting virtually.

- Recruitment is still one of the main priorities for the PD. Three recruits are graduating from the Police Academy in a couple of weeks.
- Communication Manager Patricia Tachias was elected the Women in Law Enforcement president.
