#### 4. Artist Selection Guidelines

Art Consultant Karen Constine gave an update on the Artist Selection Guidelines, policy and procedures she and Jessica Cusick have completed. Artists will be selected for programs and projects through the following proposed methods: juried service, request for proposals, request for qualifications, pre-qualified list, invitational competition, or direct selection. Funding and the amount of resources may dictate which method is used. The Commission plays a key role in the success of these processes and programs by building artist awareness and community participation via outreach and community engagement.

A future presentation will include Arts & Culture fundraising and sponsorship policies and procedures.

## 5. Ad Hoc Committees Year 22/23

Chair Filipovic led a discussion on Ad Hoc Committees for her year as Chair. Arts and Culture Manager Ben Johnson, Chair Filipovic and Vice Chair M. Beck worked together to finalize the following 22/23 Ad Hoc Committees:

- Fine Arts Frank and P. Beck
   To support all initiatives that relate to the City of Beverly Hills Fine Art Collection, Public
   Art, Art Walks, acquiring art, installation and maintenance, and fine and public arts
   programming.
- Capital Projects M. Beck and P. Beck
   To support identification and prioritization of proposed capital projects, renovations, adaptive reuse and goal setting for ensuring Beverly Hills will grow into a world-class cultural center.
- Major and Annual Events M. Beck and Filipovic
   Prioritize and identify annual and major dates, festivals, exhibitions, holidays and events until 2028 (Olympics).
- Performing Arts, Heritage Initiatives, Community Engagement Gordy Bristol and Filipovic

Identify, support and amplify music, dance, theater, literary, education initiatives for priority consideration. Identify community and cultural organizations, affinity groups, schools, businesses, consulates, and individual support and enhance Arts and Culture programs.

• Embrace and Celebrate Culture Initiative – Frank and Gordy Bristol

Participate in this Mayor's Office Initiative and response to current issues in celebrating DEI. This initiatives is a collaboration between the Arts and Culture and Human Relations Commissions, and Next Beverly Hills.

## 6. Financial Update

Paul Paolone, Senior Recreation Supervisor, reported on the Fine Art Fund and informed Commissioners on pending permits and fees. As of July 2022, there was a total of \$7,650.00 in In-Lieu Fee Revenue in FY 22/23. Aida Thau, Arts and Culture Program Associate, reported on the Fine Art Obligation. Several developers who chose to install artwork have provided progress reports as follows:

- 9242 Beverly Blvd. property installed Pae White's *Whistleblower*. Staff will be coordinating the inspection for final approval in the upcoming month.
- 136 El Camino Drive property is hoping to install Alex Israel's *The Fin* by the end of September 2022.
- 400 Rodeo Drive property will install Jean-Michel Othoniel's *Golden Lasso* tentatively scheduled for Spring 2023.
- 9000 Wilshire Blvd. property will install Heather Day's digital and augmented reality artwork at a later date dependent on construction of the building.

## PROJECT UPDATES

- Arts and Culture Commission Updates
  - Fine Art Collection Maintenance Program
     Entering the new fiscal year, staff will be reviewing the maintenance survey to identify artworks that are due for annual maintenance. The Beverly Hills Fall Art Show in October will also trigger maintenance for artworks at Beverly Gardens Park.
  - Kusama's *Hymn of Life* Refabrication Progress
    - Staff recently visited the foundry and met with Patrick Rees and the Big New staff. Director Rogers requested a quote for expedited delivery during winter BOLD holidays. The project has seen significant increases in the timeline due to inflation, labor and supply chain issues and staff will keep the Commission updated on its progress. When the artwork is authenticated, representatives from Otta Studios will be visiting and Commission leadership will be invited to join that final walkthrough / review process. When the artwork is installed, staff and the Commission will plan a ribbon cutting event in celebration of the return of the new and improved *Hymn of Life*.
  - West LA Outdoor Summer Sculpture Festival Review
     The Festival took place on Aug. 6 & 7, 2022 in partnership with Art Muse Academy the UCLA Hammer Museum and the City of Beverly Hills' Community Services Arts & Culture Division. The sculptures located at Beverly Gardens Park in Beverly Hills, at the UCLA Franklin D. Murphy Sculpture Garden at UCLA, and at the Westfield Mall and Century City, included multiple arts and crafts stations for both adults and children. The event welcomed over 130 guests from diverse backgrounds who learned more about the City's vibrant Fine Art Collection and brought multiple communities together.
- Community Services Updates
  - Arts and Culture Division Programs and Events
    - Four summer workshops including jewelry making and photography took place in the month of July. Staff are currently working on programming the upcoming fall workshops and will share dates once established. The Summer *Concerts on Cañon* music series is coming to a close with three weeks of music left, with this summer's revamped program series being celebrated as an overwhelmingly successful by the large crowds of appreciative community gathered.
