REPORTS FROM PRIORITY AGENCIES

2. Police Department Report

Sergeant Dale Drummond presented information regarding National Bicycle Safety Month and the OTS (Office of Traffic Safety) enforcement related to bicycle and pedestrian safety. He reviewed the citations and noted the most common violations were cell phone use, speed, distracted driving, stop sign and unsafe turning movements.

Lead TCO (Traffic Control Officer) Jeff Grijalva answered questions regarding the permit parking procedures and website. He relayed the Traffic Office's phone number, 310.285.2500 for questions regarding exemptions and setting up accounts. Questions/concerns can also be directed to parking@beverlyhills.org.

In June, there will be multiple events including:

- OTS Primary Crash Factor Enforcement Day
- Street Racing and Modified Vehicle Enforcement Training Course
- Monthly Maximum Traffic and Parking Deployment Day this is a coordinated effort to combat ongoing traffic issues in specific areas of the city.

The Commission inquired about DUI Training for officers.

3. Monthly Educational Speaker Series - City of San Luis Obispo Mobility Projects

Transportation Planner Jessie Holzer-Carpenter introduced City of San Luis Obispo's Transportation Planner/Engineer Jennifer Rice, who gave a presentation on that city's recent bike and pedestrian improvements. These projects included lane reductions in the downtown area to provide bike lanes and bike corrals. Projects were done in collaboration of the city's annual pavement maintenance project.

The Commission asked about any changes in retail due to less parking and increased pedestrians, the educational needs of the community when adding traffic circles and other calming devices and the durability of the green paint delineating the bike lanes.

4. Planning Quarterly Update

Principal Planner Cindy Gordon was present to answer questions on the current development projects list. The Commission asked about developers requesting increased height for their projects. Ms. Gordon explained deviations from code can be requested to provide more units under the density bonus, a state statute where if a multi-family residential development provides some amount of affordable housing, they are able to request incentives from existing development standards.

5. Clifton Le-Doux Corridor Mobility Study

Transportation Planner Jessie Holzer-Carpenter provided background on the project including information about the Metro Grant that was received to complete the feasibility study. The project study area is the Clifton-Le Doux area corridor between Cañon and La Cienega. Community feedback has been gathered in a variety of ways. Project consultant Ashley Harrick, of Alta Planning and Design, presented the draft conceptual design treatments in each block. The proposed traffic circles and curb extensions have traffic calming benefits cited in the presentation.
