- Halloween Safety: The city council passed an ordinance banning aerosol string, hair removal products, and shaving cream from October 31 to November 1. The reason for the ordinance is to minimize the crimes occurring in the area. The BHUSD staff will be in the Witches' House area.
- Tip a Cop Event will occur at CPK on Friday, October 18, from 5-9 p.m.; 20% of all food and beverages will go to the Special Olympics.
