2. PRESENTATION FROM COMMUNITY PRESERVATION DIVISION REGARDING ENFORCEMENT OF HABITABILITY AND SUBSTANDARD HOUSING VIOLATIONS RELATED TO MULTIFAMILY BUILDINGS

Staff requests that the Commission receive a presentation from the Community Preservation Division providing an overview of issues related to habitability and substandard housing violations in properties subject to the Rent Stabilization ordinance, as well as the role of Code Enforcement Officers in applying enforcement and preserving the quality of life, safety, and functionality of aging housing stock.

The Commission received the presentation from staff, asked questions regarding the procedures of Code Enforcement Officers in various situations and the responsibilities of tenants and landlords, and provided suggestions for future conversations regarding habitability. Deputy Director of Rent Stabilization Nestor Otazu indicated that staff would return with a list of habitability issues which was distributed at previous Commission discussions related to the topic, as well as more information on the viability of presenting habitability-related data sorted by new categories, including the number of cases opened by property, by landlord or tenant, and from the same individual. There was no formal action on this item.
