### 2. Amending the Wastewater Ordinance of the City of Beverly Hills

Environmental Compliance and Sustainability Manager Josette Descalzo and guest Taylor Foland from Richards, Watson & Gershon gave an update on the proposed amendments to the wastewater ordinance. The Commission asked about any potential costs of permits, how the city would enforce notification and CCTV requirements from city residents upon snaking/cleaning their drains and pipes, administrative penalties, and what was changed from the previous draft of the ordinance to this version. The Commission also asked about how these amendments to the ordinance would affect construction projects.

## 3. Lead and Copper Rule Revisions (LCRR) Update

Water Resources/Operations Manager Vince Damasse introduced guest Tori Yokoyama from Hazen & Sawyer, who gave an overview of updating the Lead and Copper Rule (LCR), including how the verification process is handled and who should be handled by. The Commission asked about the inventory of pipes in the city and how construction dates decide which homes need to have their pipes checked.
