Deputy Director of Rent Stabilization Helen Morales provided a presentation on relocation fees in connection with the no-fault eviction provisions of the Rent Stabilization ordinance, with additional information regarding 3-bedroom unit details, eviction monitoring and compliance, protections for BHUSD students and teachers, and further information on surrounding jurisdictions. The Commission discussed several sub-topics of modifying relocation fees including rental data from the City's rental registry and outside jurisdictions, vesting for long term tenants, and additional consideration for elderly and disabled residents. The Commission agreed to continue the item to the March 3, 2021 meeting for further discussion.
