DISCUSSION AND RECOMMENDATIONS TO THE BEVERLY HILLS CITY COUNCIL REGARDING POSSIBLE AMENDMENTS TO CHAPTER 5 AND CHAPTER 6 OF TITLE 4 OF THE CITY'S MUNICIPAL CODE REGARDING CURRENT RELOCATION FEE AMOUNTS. Staff seeks recommendations regarding potential amendments to Chapters 5 and 6 of Title 4 of the City's Municipal Code related to the relocation fee amounts in connection with the nofault eviction provisions of the Rent Stabilization Ordinance. *Continued from the October 6,* 2021 Rent Stabilization Commission regular meeting.

Prior to the Commission's comments on this item, City Attorney staff member Harris advised that Commissioner Miller not participate in discussions related to "mom and pop" owned

properties, as that term remains yet to be defined, and it may be determined that Commissioner Miller is a "mom and pop" property owner. Because only two landlord Commissioners were present at the meeting, Commissioner Miller's recusal resulted in a lack of quorum for such discussion, and the Commission was unable to discuss relocation fees tied to "mom and pop" properties.

Motion:	MOVED by Commissioner Tryfman, SECONDED by Commissioner Bronte to direct the City Attorney's Office to prepare a resolution stating that in light of the affected parties (AAGLA and BH Renters Alliance) requesting that relocation fees not be addressed and no recommendation to the City Council be made at this time, the Commission is tabling the request, and requesting that the City Council maintain its direction to the Commission to revisit consideration of relocation fees in three months, or such time as the City Council deems appropriate (3-3).

Motion:	MOVED by Vice Chair Baseman, SECONDED by Commissioner Miller to direct the City Attorney's Office to prepare a resolution memorializing the Commission's recommendation to the City Council that relocation fees be adjusted based on the formula of three times the median rent for the same sized unit based on the number of bedrooms, in the City's rent registry, commencing July 1, 2022, plus an additional \$1,000 for moving expenses plus an additional \$2,000 for a household with a qualifying member (senior, disabled, or minor tenant); if insufficient data exists for a particular year, the prior year's data shall be used (4-2).

THE CITY'S MUNICIPAL CODE REGARDING BEVERLY HILLS HABITABILITY STANDARDS; PROACTIVE INSPECTIONS; A MEDIATION BOARD TO ADDRESS HABITABILITY VIOLATIONS AND ASSOCIATED RENT REDUCTIONS; AND TO RESTRICT RENT INCREASES.
