BHMC 10-3-2516 D: WALLS, FENCES AND HEDGES:
Front And Street Side Yards: No wall or fence shall be located within three feet ( $3^{\prime}$ ) of a front lot line or street side lot line. Walls or fences located more than three feet ( $3^{\prime}$ ) from a front lot line or street side lot line, but less than or equal to ten feet (10') from a front lot line or street side lot line shall be no more than three feet ( $3^{\prime}$ ) in height.
Walls or fences located more than ten feet (10') from a front lot line or street side lot line, but within a front yard or street side yard, shall be no more than six feet ( $6^{\prime}$ ) in height. Furthermore, any portion of such walls or fences that exceeds three feet ( $3^{\prime}$ ) in height shall be open to public view.
