## 2) REVIEW OF DRAFT PROVISIONS FOR THE JOINT POWERS AGREEMENT (JPA) WITH THE BEVERLY HILLS UNIFIED SCHOOL DISTRICT

The following discussion points were covered:

- Cost Analysis: the District will provide the information to the City after Wednesday, August 16, 2017.
- Joint Use Calendar: both the City and the District agreed to creating a joint calendar.
- Crossing Guard Payments: City Council to consider paying 50% of annual costs.
- Priority use by Beverly Hills Education Foundation (BHEF) and the Parent Teacher Association (PTA) over City use for school sponsored activities: consideration of redrafting Agreement language to incorporate under District use with approval required by Superintendent or designated staff.
- District's special event costs for Police and Fire Department: Council consideration of waiving costs up to a certain not to exceed amount.
- Supervision during City usage time: to be determined after review of cost analysis.
- District extension of the current temporary JPA extension to allow more time for discussion: the City allowed extension up to six (6) months. District agreed to two (2) month extension which expires on August 31, 2017. District will consider a further

extension at their next Board meeting. If not extended, the City requested the ability to rent District facilities in the interim or advised alternate locations will be sought.

- The issue of adults using the school fields was discussed. The absence of a permit will be enforced. The Ambassadors received praise for their presence.
- The next meeting will be held on August 23, 2017 at 10:00am at City Hall on the 4<sup>th</sup> Floor, Conference Room A.
