Dear Mr. Welch and Ms. Wilson:

Environmental Intelligence, LLC (EI) has been retained by the City of Beverly Hills (COBH) and the Los Angeles County Metropolitan Transportation Authority (Metro) to serve as the independent compliance monitor (ICM) during construction of the Purple Line Extension Project. Monitoring is required to ensure that construction is in compliance with the "Memorandum of Agreement for Contract C1120 of the Purple Line Extension Project - Between the City of Beverly Hills and the Los Angeles County Metropolitan Transportation Authority" (Final Version 62). The following information summarizes the ICM monitoring activities that occurred at the Segment 2 site (Rodeo Station site) during the week of May 29, 2022 – June 4, 2022.

Construction activities during the week included: implementing lane closures; receiving drilling equipment and conducting drilling operations on Lasky Dr.; saw-cutting pavement in anticipation of dewatering activities on Lasky Dr.; conducting construction support activities below deck on Wilshire Blvd.; working within the Reeves and Canon yards; hoisting out and lowering construction materials through the deck panel access on Wilshire Blvd.; geotechnical instrument maintenance work on Wilshire Blvd.; receiving construction materials deliveries; and sweeping and cleaning the work site. In addition, EI ICMs conducted sound monitoring and MOA compliance reviews near the back alley of the Beverly Hills High School bungalows adjacent to the project site. EI ICMs were present during all construction activities and conducted routine noise measurements at selected noise monitoring locations as well as compliance checks in accordance with the MOAs and associated attachments, exhibits, traffic closure notifications, and traffic management plans. At the conclusion of each work shift, daily monitoring reports were prepared by each ICM. Attachment B (*Daily Monitoring Reports*) provides detailed daily monitoring reports and photographs of construction activities.

VIOLATION SUMMARY

During the week, EI ICMs identified two (2) violations during construction activities. Table I provides a summary of the violations identified during the week of May 29, 2022 to June 4, 2022. Exhibit 1 provides a location map for the submitted violations. Details for the violations are included as Attachment A. Daily monitoring reports and photographs of construction activities are provided as Attachment B (*Daily Monitoring Reports*). Daily noise monitoring data are provided in Attachment C (*Noise Monitoring Data Log*).

To date, 571 violations have been issued, twenty-one (21) of which have been rescinded since the beginning of construction of the Purple Line Extension Project – Segment 2. Please note, no Violation 261 was ever issued, therefore it is skipped in the numbering sequence and is omitted from this count. Project construction activities are ongoing and EI ICMs continue to monitor all construction activities applicable to the MOA on a daily basis.
