- 11) Discuss Potential Avenues for Legislation Regarding Street Racing
  - Presented by Chief of Police Sandra Spagnoli
  - Council Liaisons discussed several options to explore invlufinh :
    - Partnering with CHP to either author or amend existing legislation to strengthen regulations on drivers and witnesses of street racing.
    - Explore speeding cameras (similar to red light cameras) in residential areas.
    - Confiscating automobiles
    - Targeted enforcement
    - Staff will continue to research options to strengthen legislation
