Insurance Requirement

Example for Remodels, Concrete, Excavation, Equipment, Ext. Paint or Wash Bldgs.

GENERAL AND AUTO LIABILITY INSURANCE MUST BE PROVIDED TO THE CITY OF BEVERLY HILLS BY THE CONTRACTOR OR OWNER/BUILDER BEFORE HAULING OR STREET USE PERMITS WILL BE ISSUED. THE LIMITS OF LIABILITY ARE DETERMINED BY THE TYPE OF CONSTRUCTION BEING DONE. BELOW IS A "SAMPLE" CERTIFICATE FOR REPAIRS & MAINTENANCE WORK, ADDITIONS AND/OR REMODELING WORK. **HIGHER LIMITS OF INSURANCE ARE REQUIRED FOR DEMOLITION OF EXISTING HOMES, CONSTRUCTION OF NEW HOMES AND NEW COMMERCIAL BUILDINGS.
