Winners receive performance engagements and recognition at *Music in the Mansion Festival* (City of Beverly Hills' Greystone Mansion 3rd week of April 2024), as well as an engagement considerations by members of the *Consortium of Southern California Chamber Music Presenters*, including *Classical Sundays at Six* at St. James in the City (formerly *Sundays Live!* at LACMA), *Laguna Beach Live!*, *Classical Crossroads' "First Fridays at First!~fff"* & *"Second Sundays at Two"*, and more than 40 other Southland concert series.

Each winning artist/ensemble receives an honorarium, with the event publicized online and in local newspapers. Auditions are open to instrumentalists, pianists, vocalists and chamber ensembles.

Now in its 29th Season, designated a "Best Bet" by the *Los Angeles Times* and a "Pick of the Week" by *L.A. Weekly*, "the series is a much sought opportunity for performers...The talent level is extremely high." - *Los Angeles Times*

Auditions Requirements

- Auditions are open to professional musicians from age 20. Live audition time: about 15 minutes.
- At least two contrasting pieces are required for the audition; for example: Classical & Romantic periods. Must include a short virtuoso selection (if the virtuoso selection is from the Romantic period that satisfies both requirements). It is recommended to offer 4-5 compositions for the audition (including some from the applicant's proposed recital program), as the committee prefers to see a wide selection and may request short "samplings".
- Application must include: artist's repertoire list, a suggested recital program of 60 minutes without intermission, and a biography.
- Winners will be announced on Sunday, April 23, 2023. Notification of the performance dates will follow by email/phone.
- The Consortium's concert-series presenters will make separate concert arrangements with the selected artists/ensembles.
