### **3. 500 Block of North Crescent Drive Preferential Parking Permit Zone**

Consideration of a resident-initiated request for a daytime preferential permit parking zone for the 500 block of North Crescent Drive.

Speakers: Howard Landres, Auralee Rothman Ring

Transportation Planning Analyst Christian Vasquez presented a report for consideration of a resident-initiated petition to establish a preferential permit parking zone for the 500 block of North Canon Drive. The original petition requested "No Parking Anytime", while staff recommended establishing "2-Hour Parking, 8 a.m. to 8 p.m., Monday through Saturday, and No Parking, 8 p.m. to 2:30 p.m., Daily, Permit 'BT' Exempt" for consistency with neighboring street permit regulations.

Motion: MOVED by Commissioner Hendry, SECONDED by Commissioner Manaster to approve the establishment of "2-Hour Parking, 8 a.m. to 8 p.m., Monday through Saturday, and No Parking, 8 p.m. to 2:30 a.m., Daily, Permit 'BT' Exempt (5-0)

### **4. Preferential Parking Permit Districts**

Continue discussion of the proposed Preferential Parking Permit districts process.

Speakers: Claudette Zelkha, David Kron

Transportation Planner Martha Eros provided a report outlining the Preferential Permit Parking (PPP) zone consolidation process for residential segments of the 100 blocks south of Wilshire Boulevard between Spalding and South Camden Drives. Staff recommended establishing a PPP zone on the 100 block of McCarty Drive, and modifying the PPP zones on the 100 blocks south of Wilshire between Spalding and South Camden Drives, with a consistent permit parking regulation of "No Parking, 8:00 a.m. to 2:30 a.m., daily, permit zone 'AD' exempt".

Staff provided a “No Parking Anytime” alternative in lieu of “No Parking, 8 AM to 2:30AM, Daily”. The Commission supported the consolidation, and chose to use the language as stated in the public notice.

Motion: MOVED by Commissioner Seidel, SECONDED by Commissioner Manaster to establish a Preferential Parking Permit zone on the 100 block of McCarty Drive with a regulation of “No Parking 8 a.m. to 2:30 a.m. daily, with a zone designation ‘AD’” (5-0)

Motion: MOVED by Commissioner Manaster, SECONDED by Commissioner Hendry to approve modifying the Preferential Parking Permit zones on the 100 blocks south of Wilshire Boulevard between Spalding and South Camden Drives with a consolidated regulation of “No Parking, 8 a.m. to 2:30 a.m., daily” with a Zone “AD” designation (5-0)
