**B. Direction**

1. State and Federal Legislative Updates

- Jamie Jones provided updates on H.R.6 – American Dream and Promise Act, the Paycheck Protection Program, and the Transportation Infrastructure Bill.
- Andrew Antwih provided updates on State Budget, Funding for Homelessness, Housing Bonds, appointment of the State Attorney General and Vaccine Distribution.

2. Assembly Constitutional Amendment 7 (Muratsuchi) - Local government: police power: municipal affairs: land use and zoning
  - The Liaisons support the Assembly Constitutional Amendment 7 in concept.
  - Language is not clear enough for affirmative support.
3. Assembly Bill 816 (Chiu) - State and local agencies: homelessness plan
  - Liaisons oppose AB 816 as it does not provide funding to cities to support the mandate.
4. Assembly Bill 1119 (Wicks) - Employment discrimination
  - Liaisons support AB 1119.
5. Assembly Bill 1372 (Muratsuchi) - Right to temporary shelter
  - Liaisons oppose AB 1372 as it does not provide funding to cities to support the mandate.
6. Senate Bill 82 (Skinner) - Petty theft
  - Liaisons do not support SB 82.
7. Senate Bill 284 (Stern) - Workers' compensation: firefighters and peace officers: post-traumatic stress
  - Liaisons do not support SB 284.
  - It is difficult to prove that PTSD is a direct result of the job.
8. Senate Bill 612 (Portantino) - Electrical corporations and other load-serving entities: allocation of legacy resources
  - Liaisons support SB 612.
9. Senate Bill 679 (Hertzberg) - Los Angeles County: housing development: financing
  - Liaisons support SB 679.
10. Senate Bill 765 (Stern) - Accessory dwelling units: setbacks
  - Liaisons support SB 765.
  - Different jurisdictions can have different needs and space requirements.
11. Senate Bill 809 (Allen) - Multijurisdictional regional agreements: housing element
  - Liaisons support SB 809.
