Mark Elliot spoke on issues relating to rent burdened residents and resources to keep peopled housed.

## 2) Community Education

Enisha Clark, Human Services Outreach Manager, introduced Consultants Abby Arnold and Jenny Swan who provided information on the rights of Unhoused.

3) Update on Enhanced Services to the Unhoused

Christopher Paulson, Human Services Administrator, provided an update on the Enhanced Services since the City Council's approval on November 15, 2022.

- Implementation of a centralized 24-hour phone number
- Implementation of a Software System (Apricot 360)
- Expansion of Outreach Coverage
- Consultant & Homelessness Plan

Additional Service Enhancements and Collaboration:
 Kevin Conner, Lead Outreach Service Coordinator, provided information on the
 services that Step Up on Second provides in addition to the challenges they
 encounter.

Todd Withers, BHPD, provided an update on the services the MET Officer Team provides.

Consultants Abby Arnold and Jenny Swan have been meeting with stakeholders in addition to overseeing a survey. They'll return with their proposed plan in a few months.

Mayor Gold requested a push for a higher percentage response from residents. Councilmember Bosse requested that the software, Apricot 360, additionally log what services people are requesting. Staff is logging this information and it will be presented at the next meeting.

Councilmember Bosse asked for an update on the two social workers that the County of Los Angeles is to provide. Stephanie Harris provided the update from the County that they are still in the hiring process.

# 4) Housing Opportunity – Step up on Second

Following a presentation on a housing opportunity with Step Up on Second, City Council Liaisons provide direction to staff on the desire to bring forward a complete proposal for consideration to the full City Council to contract with Step Up on Second for scattered-site permanent supportive housing units for the unhoused for an initial 10-year term.

City Council Liaisons agreed to bring to a Study Session in July 2023.
