# 2) REVIEW OF DRAFT PROVISIONS FOR THE JOINT POWERS AGREEMENT (JPA) WITH THE BEVERLY HILLS UNIFIED SCHOOL DISTRICT

BHUSD informed City staff that they have not submitted the Agreement to their attorney as both sides are represented by the same legal counsel. They requested the City to submit the necessary approval for purview of the Agreement or the District will need to retain a different legal counsel.

BHUSD acknowledged receiving the City's counter-proposal and presented to the City their proposal of a four year with annual increases based on increased costs of resident usage, utilities, insurance and minimum wage.

After discussion, Vice Chair Gold and Councilmember Mirisch reviewed the following pending issues:

- BHUSD have an attorney review the language of the proposed Agreement.
- Based on new proposal information provided to City Council, it's unlikely a new JPA can be resolved in eight days.

- Option to extend an interim agreement in order to resolve outstanding issues
- Option to increase JPA as requested by BHUSD.
- Both parties review cost spreadsheets associated with usage

BHUSD is to advise City Council of their direction after meeting with their Board today.

Rick Wolfen expressed his concern of the JPA contract being eight days away and there will not be facilities available to the community.

A.J. Willmer additionally expressed his concern and suggested a one year agreement would be best to allow time for additional issues to be resolved.
