
Who we are

GDP of California



The Gross Domestic Product (GDP) of California was approximately \$3.89 trillion in 2023, according to the U.S. Bureau of Economic Analysis. California has the largest state economy in the United States, and if it were a country, it would rank as one of the largest economies in the world.

GDP of Los Angeles County



Los Angeles County's GDP was around \$790 billion in 2023. The county is a major contributor to the state's economy, with significant inputs from entertainment, manufacturing, international trade, and technology sectors.

Living Wage


The living wage in Los Angeles County varies depending on various factors such as household size and specific expenses. However, estimates suggest that for a single adult, the living wage needed to cover basic expenses without relying on outside help is around \$23 per hour, according to a report from the MIT Living Wage Calculator around 2023. For families with children, this figure increases significantly.

Average Home Price

The average home price in Los Angeles County has experienced fluctuations, but as of early 2023, it was around \$800,000 to \$900,000. The housing market in Los Angeles is known for its high prices, contributing to the affordability challenges many residents face.








Professional Sports Teams

Professional Sports Teams

Los Angeles is home to a number of professional sports teams across different leagues, including the NBA (Los Angeles Lakers and Clippers), MLB (Los Angeles Dodgers and Angeles), NFL (Los Angeles Rams and Chargers), NHL (Los Angeles Kings), and MLS (LA Galaxy and Los Angeles FC). The presence of these teams supports thousands of jobs, from athletes and coaching staff to venue workers and those in supporting industries. It also drives significant revenue from ticket sales, merchandise, and broadcasting rights.

Routine Sporting Events

Los Angeles Marathon: An annual event typically held in March, running from Dodger Stadium to Santa Monica.

LA Galaxy and Los Angeles FC Matches: The Major League Soccer season runs from late February/early March through October, with playoffs extending into November.

Los Angeles Dodgers Games: The Major League Baseball season typically starts in April and can go through to the end of October, depending on playoff progression.

Los Angeles Lakers and Los Angeles Clippers Games: The NBA season runs from October to April, with playoffs extending into June.

Los Angeles Rams and Chargers Games

Los Angeles Kings and Anaheim Ducks Games: The NHL season runs from October to April, with playoffs extending into June.

Rose Bowl Game: An annual college football game played on January 1 in Pasadena.

The Genesis Invitational: An annual professional golf tournament held at the Riviera Country Club in Pacific Palisades, typically in February.

Long Beach Grand Prix: An annual IndyCar race typically held in April in Long Beach.

Film and Television Industry

Hollywood, the heart of the global film and television industry, is a major contributor to LA's economy. It not only generates direct revenues from productions but also supports a vast network of ancillary services, including post-production, marketing, and distribution. The film and television industry is a significant employer in the region and attracts talent from across the world.

Film & Television Economic Output

The California Film and Television Tax Credit 2.0, enacted in July 2015 and sunsetting June 2020, has contributed almost \$21.9 billion in economic output over five years, supporting more than 110,000 total jobs (includes direct, indirect, and induced) in California. This increase in economic activity has returned to state and local governments an estimated \$961.5 million in tax revenue. For every tax credit dollar approved under California's Film and Tax Credit program, at least \$24.40 in output, \$16.14 in gross domestic product (GDP), \$8.60 in wages, and \$1.07 in initial state and local tax revenue will result from production in the state of California.



Music and Performing Arts

Los Angeles is a major hub for the music industry, encompassing record labels, recording studios, and a vibrant live music scene. The city's theaters and performing arts centers, such as the Walt Disney Concert Hall and The Broad Stage, contribute to LA's cultural richness and economic vitality.





Economic Impact

This includes substantial tax revenues for local and state governments. 
