PART A: TIME LIMITATIONS FOR FILING APPLICATIONS UNDER BHMC SEC. 4-3.204(B)(1) OR (2):

- 1. Not less than six (6) days prior to date** of parade or assembly if proposed to take place in whole or in part on a roadway portion (other than moving within crosswalks) of Wilshire Boulevard, Olympic Boulevard, Santa Monica North Roadway, Sunset Boulevard, La Cienega Boulevard or Robertson.
- 2. Not less than four (4) days prior to date** of parade or assembly proposed to take place in whole or in part on a roadway portion (other than moving within crosswalks) of any other street in a commercial zone within the City.

If either Section 1 or Section 2 applies, the City Manager or his designee shall approve or deny the permit application **within two (2) days** after submission of the completed application.

 PART B: TIME LIMITATIONS FOR FILING APPLICATIONS UNDER BHMC SEC 4-3.204(B)(3) OR (4):

- 3. Not less than three (3) days prior to date** of parade or assembly if proposed to take place **either** in whole or in part on, in, or along a roadway, sidewalk, or public right of way in a non-commercial zone, **or** outside the roadway but within the sidewalk or any other portion of the public right of way in a commercial zone.
- 4. Not less than two (2) days prior to date** of parade or assembly proposed to take place in whole or in part in or along any park or other publicly owned traditional public forum in the City of Beverly Hills not covered by sections (1) through (3) above.

If either Section 3 or Section 4 applies, the City Manager or his designee shall approve or deny the permit application **within twenty-four hours** after submission of the completed application.
