**Subject:** Segment 2 - Purple Line Extension Project ICM Weekly Report  
**March 15, 2020 – March 21, 2020**

Dear Mr. Welch and Mr. Comorre:

Environmental Intelligence, LLC (EI) has been retained by the City of Beverly Hills (COBH) and the Los Angeles County Metropolitan Transportation Authority (Metro) to serve as the independent compliance monitor (ICM) during construction of the Purple Line Extension Project. Monitoring is required to ensure that construction is in compliance with the "Memorandum of Agreement for Contract C1120 of the Purple Line Extension Project - Between the City of Beverly Hills and the Los Angeles County Metropolitan Transportation Authority" (Final Version 62). The following information summarizes the ICM monitoring activities that occurred at the Segment 2 site (Rodeo Station site) during the week of March 15, 2020 – March 21, 2020.

Construction activities during the week included closure of the Wilshire Blvd. and Beverly Dr. intersection, drilling at pile locations, loading drill spoils into haul trucks for off-site removal, receiving steel I-beam pile deliveries, fabricating, installing and framing piles, pouring concrete and concrete injections, excavating for pile cap installation, vacuum truck excavation at pile locations on Wilshire Blvd. backfilling and compacting pile line trench, breaking pavement and concrete and cleaning and sweeping the site. In addition, EI ICMs also monitored geotechnical instrumentation work at various locations on Lasky Dr., S. Moreno Dr. and Young Dr. EI ICMs were present during all construction activities and conducted routine noise measurements at selected noise monitoring locations as well as compliance checks in accordance with the MOAs and associated attachments, exhibits, traffic closure notifications, and traffic management plans. At the conclusion of each work shift, daily monitoring reports were prepared by each ICM. Attachment B (*Daily Monitoring Reports*) provides detailed daily monitoring reports and photographs of construction activities.

## **VIOLATION SUMMARY**

During the week, EI ICMs identified six (6) violations during construction activities. Table I provides a summary of the violations identified during the week of March 15, 2020 to March 21, 2020. Exhibit 1 provides a location map for the submitted violations. Details for the violations are included as Attachment A. Daily monitoring reports and photographs of construction activities are provided as Attachment B (*Daily Monitoring Reports*). Daily noise monitoring data are provided in Attachment C (*Noise Monitoring Data Log*).
