REPORTS FROM PRIORITY AGENCIES

- Beverly Hills Unified School District (BHUSD) Beverly Hills Unified School District representative Rachelle Marcus spoke about the District's Community Pledge and Civility Bylaw and the successful commencement of another school year. Rachelle introduced Beverly Hills High School Associated Student Body President Ashley Jourabchi and Student Board Member Alix Boddin who addressed Commission inquiries.
- Beverly Hills Police Department Lieutenant Giovanni Trejo updated the Commission on incidents and community outreach programs, including Neighborhood Watch and Citizen's Academy. The Police and Fire Departments conducted an Active Shooter training exercise on August 12, 2022 at Hawthorne Elementary School. The training exercise entailed collaboration from members of the Beverly Hills Unified School District, City partners,

community members for the safety of students, faculty, and anyone who works and visits the schools.

 Beverly Hills Fire Department – A-Shift Platoon Battalion Timothy Hayes spoke on incidents and response metrics. He reported on staff training, continuing education as well as the Active Shooter training exercise held at Hawthorne Elementary School for student safety. He spoke on the completion of the City's brush inspections and the Rapid Extraction Module Support (REMS) deployment to the Oak Fire in Mariposa County and Yeti Complex Fire in Northern California near the McKinney Fire. There were no injuries reported.

3. Health and Safety Recognition Program

The Health and Safety Commission will honor those who have demonstrated leadership in the field of health and safety issues or contributed to the mission of the Health and Safety Commission. The Commission will recognize Shirley Reitman, Southern Coordinator for the JUST IN CASE BEVERLY HILLS program and member of the Police Department's Chief Advisory Panel.

The Commission recognized community leader Shirley Reitman for the Health and Safety Recognition Program.

4. COVID-19 Update

Emergency Manager Meena Janmohamed updated the Commission on a variety of COVID-19 metrics including cases, vaccination, and statistics specific to the Beverly Hills community. Staff reviewed the current Los Angeles County COVID-19 community levels and protective measures. Staff also provided an overview on Monkeypox, spoke on the current health order and the City's continued response to the pandemic. Staff addressed Commissioner inquiries.

Provides an informational update on the status of the Citywide Outdoor Warning Siren System.

Emergency Manager Meena Janmohamed provided an update on Citywide Outdoor Warning Siren System. The update includes providing an additional layer of emergency

notification redundancy, primarily for those who are outdoors. The Public Works Department is working in conjunction with the Office of Emergency Management. The City is looking forward to receiving bid proposals from vendors. Staff plans to bring the item forward to the City Council in mid-Fall.

6. Power Outages and Preparedness Tips

A presentation by Southern California Edison on electrical power outages and preparedness.

Southern California Edison Government Relations Manager Diane Forte and Business Customer Division Outage Team Manager Eric Taitano presented to the Commission. Eric Taitano gave an overview of the different types of outages, which included maintenance outage, repair outage, emergency outage, and rotating outage. He shared ways the community can keep informed and on building an outage preparedness kit. The outage team is working alongside the Office of Emergency Management to provide tips and other resources to the community.

9. Climate Action and Adaptation Plan (CAAP) Update

A progress summary for the Climate Action and Adaptation Plan including activities completed to date and upcoming steps towards the adoption of the Climate Action and Adaptation Plan.

David Gingold provided a public comment.

Environmental Compliance and Sustainability Programs Manager Josette Descalzo provided an update on greenhouse gas mitigation measures and its priority mitigation measures of carbon free electricity, building decarbonization, complete streets plan and other transportation mode shifts, clean vehicle measures, and compliance with SB 1383 organics and food waste diversion. He also discussed adaptation measures and its priorities, which included community awareness, emergency response, heat mitigation and increased safety, wildfire and flood mitigation, and climate/resilience benefits in capital improvement planning and building design.

Staff thanked Vice Chair Hilborne and Commissioner Felsenthal for their participation as the Health and Safety Commission representatives in the Community Advisory Committee for the Climate Action and Adaptation Plan.
