### Insurance Requirement

#### Example for Dumpster, Ladders, Painting, Cones or Any Sidewalk R-O-W

**GENERAL AND AUTO LIABILITY INSURANCE MUST BE PROVIDED TO THE CITY OF BEVERLY HILLS BY THE CONTRACTOR OR OWNER/BUILDER BEFORE HAULING OR STREET USE PERMITS WILL BE ISSUED. THE LIMITS OF LIABILITY ARE DETERMINED BY THE TYPE OF CONSTRUCTION BEING DONE. BELOW IS A "SAMPLE" CERTIFICATE FOR REPAIRS & MAINTENANCE WORK, ADDITIONS AND/OR REMODELING WORK. \*\*HIGHER LIMITS OF INSURANCE ARE REQUIRED FOR DEMOLITION OF EXISTING HOMES, CONSTRUCTION OF NEW HOMES AND NEW COMMERCIAL BUILDINGS.**
