About the Preschool

Background

The City of Beverly Hills Community Services Department proudly offers a year-round preschool program at 4 classroom sites for children 3 - 5 years of age. Children must be toilet-trained before starting the program.

Although these programs are recreational in nature, fundamental building blocks and tools necessary for a child to successfully integrate into Transitional Kindergarten and Kindergarten are provided. These programs prepare children for Transitional Kindergarten and Kindergarten through the development of socialization and interaction skills.

Children will learn the basics such as ABC's, colors, shapes, numbers, and begin their appreciation of the arts and science. Parents/Guardians must provide lunch each day their child attends.

All children are encouraged to realize their full potential, while at the same time, helping them to recognize socially acceptable norms within the preschool environment as stepping stones to Transitional Kindergarten and Kindergarten.

The City of Beverly Hills preschool sites are licensed by the state of California and comply with all guidelines and requirements. All programs embrace the highest standards of conduct, health, and safety.

Program Information

Program Philosophy

Early childhood should be a time of joy, comfort, excitement, exploring, and discovery. Preschool age children are both open and receptive. Teachers nurture and encourage these qualities in students through a combination of structured group time and individual creative learning in a positive environment. A development approach is utilized and provides experiences which promote curiosity and develop cognitive, language, social, and fine and gross motor skills. Children are encouraged to actively explore their environment and acquire skills through a combination of play, small and large group activities, and direct instruction.

Teaching Staff

Staff instruct in a caring and cooperative team teacher format. All sites have an on-site director (Head Teacher), a Teacher and a Teacher's Assistant. All teachers have a background in Early Childhood Education and meet all State Licensing teacher qualifications.

Hours of Operation and Payment

All school sites are offered Monday-Friday from 9am to 2pm. Registration costs approximately \$10,759 a year and is split into quarterly payments.

Registration and Waitlist

Interested applicants may apply for the waitlist starting at 1 year old. Beverly Hills residents will receive first priority. Non-residents will be placed on a waitlist for the preschool locations at park sites only. (P.O. Boxes or business addresses do not qualify as a resident.)

The following information is REQUIRED to be placed on the waiting list:

- A photocopy of your current water bill or Southern California Edison bill.
- A photocopy of your child's birth certificate.
- A non-refundable \$25 waiting list fee.
- Child must be 1 year old to be placed on the waiting list.
