2) 2017-2018 Beverly Hills Chamber of Commerce Work Plan - Addendum

- Todd Johnson provided an update about individual projects and assignments being worked on through the Beverly Hills Chamber of Commerce.
- Blair Schlecter presented information on the proposal submitted by Responsible Hospitality Institute (RHI) for the Beverly Hills Nightlife Study. The focus of the study is to create a comprehensive outlook on the nightlife in Beverly Hills and how to later develop that nightlife.
- Mayor Bosse and Councilmember Friedman advised to move forward with Option B of the RHI proposal.
- Blair Schlecter presented information on the outreach and marketing plans for the holiday BOLD programming. The Chamber of Commerce advised that it will greatly expand its outreach efforts in comparison to the summer BOLD outreach as the entire city will be involved in the programming.
- Mayor Bosse and Councilmember Friedman supported the Chamber's outreach and marketing plan.
- Charisse Older presented information on the Beverly Hills Tomorrow event.
- Mayor Bosse advised the Chamber to eliminate the complimentary and reduced-price tickets from the event budget. Councilmember Friedman concurred.
