- Dr. Kotkin provided a presentation on "The Case for Localism" with key solutions of:
 - Reforming California Regulatory rules to be more friendly to the middle class;
 - Focusing on developing higher paid employment options; and
 - Transportation solutions should be for the 21st century.
- Dr. Kokin is looking for funding to conduct a study. Other jurisdictions such as West Hollywood, Buena Park, and Anaheim could be invited to participate.
- Councilmember Mirisch recommended the City advocate for local control from an urban planning perspective. Requested urban planning be added to the City's Legislative Platform.
- Dr. Gold recommended Dr. Kotkin provide presentation to the California Contract Cities Association and California League of Cities.

- Liaisons requestd to continue to monitor AB 1250 as it is a two-year bill.
