Request for a General Plan Amendment, Zone Text Amendment, Planned Development, and Vesting Tentative Tract Map to create a Residential Overlay Zone and allow a five-story, mixed-use project consisting of 27 residential condominium units and ground floor retail in a Commercial Zone on the property located at 9908 South Santa Monica Boulevard.
