NOTICE OF HEARING RIGHTS

YOU HAVE THE RIGHT TO A HEARING, IF YOU BELIEVE YOUR VEHICLE SHOULD NOT HAVE BEEN IMPOUNDED. THE PURPOSE OF THE HEARING IS TO DETERMINE WHETHER THERE WAS PROBABLE CAUSE TO IMPOUND THE VEHICLE. FAILURE TO REQUEST A HEARING WITHIN TEN (10) DAYS OF THE NOTICE OR FAILURE TO ATTEND A SCHEDULED HEARING WILL END YOUR RIGHTS TO A HEARING.
